DOSO is of the opinion that stunning and killing – whichever method applied - must be followed immediately by bleeding and that words to that effect should be added as introduction to both chapters.

<u>Chapter 7.10</u>. Animal welfare and broiler chicken production systems.

2. Environment and management, c) Air quality:

'Ammonia concentration should not routinely exceed 25 ppm at broiler level.'

I) Painful interventions,
such as beak trimming, toe trimming and dubbing, should not be routinely practised on

such as beak trimming, toe trimming and dubbing, should not be routinely practised on broilers.

DOSO recommend that the word 'routinely' is deleted in paragraphs c) and l)

q) On farm harvesting.

DOSO recommend that the word 'harvesting' is replaced (gathering for slaughter) in realisation of the fact that the chapter deals with sentient beings – not industrial elements. Words are important. They determine our attitude and thereby our treatment of the subject described.

<u>Chapter 7.11.</u> Animal welfare and dairy cattle production systems <u>13.m</u>) Painful husbandry procedures.

DOSO recommend that the paragraph read: <u>Such procedures should be performed at as early an age as possible using anaesthesia or analgesia by a veterinarian or under supervision of a veterinarian.</u>
